## Rules of the Board of the Council of Engineers on Appointment of Honorary Members, B.E. 2544 (A.D. 2001)

By virtue of Section 11 (3), Section 12, and last paragraph of Section 33 (3) of the Engineer Act, B.E. 2542 (A.D. 1999), the Council of Engineers issues these Rules as follows:

Clause 1. These Rules shall be called "Rules of the Board of the Council of Engineers on Appointment of Honorary Members, B.E. 2544 (A.D. 2001)."

## Clause 2. In these Rules:

"Subcommittee of the Council of Engineers Office" means a group of persons appointed by the Council of Engineers to hold the position to consider appointing honorary members and to have the powers and duties as prescribed in the Engineer Act, B.E. 2542 (A.D. 1999).

Clause 3. These Rules shall come into force from the day following the date of announcement onwards.

Clause 4. A person to be appointed as an honorary member shall have qualifications and not be under the prohibitions as follows:

- (1) Being not less than forty years of age;
- (2) Not having violated the professional ethics as prescribed in the Rules of the Council of Engineers;
- (3) Not having been sentenced by a final verdict of the Court of Justice to a term of imprisonment in violation of the code of ethics in such a manner that disgraces the engineering profession specified in the Rules of the Council of Engineers; and
- (4) Not being a person of unsound mind, a seriously handicapped person or being afflicted with a disease specified in the Rules of the Council of Engineers.

A person qualified for being an honorary member shall have the following qualifications:

- (1) Having an academic degree in engineering or applied sciences with outstanding engineering achievement, which is beneficial to the country;
- (2) Not having an academic degree in engineering or applied sciences, but having the outstanding engineering achievement, which is beneficial to the country; or
- (3) Having or not having an academic degree in engineering and greatly promoting and supporting engineering work to significantly benefit the country and the general public.

Translation

Clause 5. President of the Council of Engineers shall appoint a subcommittee to collect and submit the names along with backgrounds and achievements of qualified candidates to the Board of the Council of Engineers to select one or more candidates as the honorary members.

Clause 6. President of the Council of Engineers shall present a list of persons being selected as the honorary members to the general meeting to consider appointing such persons as the honorary members.

Clause 7. President of the Council of Engineers shall present certificates and badges of appreciation to the honorary members and enter their names in the register of honorary members of the year in which they are appointed by the general meeting.

Clause 8. Chief of the Council of Engineers shall maintain and keep the register of honorary members.
