Rules of the Board of the Council of Engineers
On Practical Academic Test at the Adjunct Engineer Level,
B.E. 2544 (A.D. 2001)

By virtue of Clause 9 of Rules of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer, B. E. 2543 (A.D. 2000), the Council of Engineers issues these Rules as follows:

Clause 1. These Rules shall be called "Rules of the Board of the Council of Engineers on Practical Academic Test at the Adjunct Engineer Level, B.E. 2544 (A.D. 2001)."

Clause 2. These Rules shall come into force from the day following the date of its publication in the Government Gazette onwards.

Clause 3. In these Rules:

Board means the Board of the Council of Engineers.

Subcommittee means the subcommittee or special experts of relevant fields of the engineering profession appointed by the Board to consider the achievements and quantity of works and to conduct the academic test in relation to provision of readiness to practice the regulated engineering profession.

Applicant means a person applying for a license to practice the regulated engineering profession at the adjunct engineer level.

Clause 4. The Applicant shall file an application in the form of "Application for the Regulated Engineering Profession Practitioner License at the Adjunct Engineer Level" along with the form of "List of Quantity of Works and Achievements in Practicing the Regulated Engineering Profession to Apply for the Adjunct Engineer License" of the Council of Engineers. Document indicating the completed works by the Applicant shall bear the signature of an engineer at the professional engineer level or higher in the same field or discipline with the Applicant.

The Applicant may file an application for only one type of work on which he/she is experienced at a time. If the Applicant wishes to apply for the license for the other type of work, another application shall be filed.

Clause 5. The Subcommittee shall consider the achievements and quantity of works and test the Applicant's knowledge to practice the regulated engineering profession. If the Applicant meets the criteria set, he/she shall attend the training to get ready to practice the profession before being granted the license.

Clause 6. The Applicant shall have the competence and qualifications matching the type of work applied for as prescribed by the Rules of the Board of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer, B.E. 2543 (A.D. 2000).

Clause 7. The Applicant shall have the knowledge and experience matching the type of work for which the license is applied and within the scope of engineering profession. The criteria for issuing the license shall be at the Subcommittee's discretion.

Clause 8. When the Applicant's achievements meet the criteria, the Subcommittee shall consider conducting an interview and/or a written examination. For the Applicant who fails the interview or written examination, if he/she wishes to apply for the license for the same type of work, a new application may be filed not less than six months after submission of the earlier application.
