## COUNCIL OF ENGINEERS REGULATION on the Issuance of Licenses to Practise the Regulated Engineering Profession (Adjunct Engineer) (No. 2), B.E. 2555 (2012)

Whereas it is deemed appropriate to amend the Regulations of the Council of Engineers on the Issuance of Licenses to Practise the Regulated Engineering Profession at the Associate Engineer (Special) Level, by virtue of Section 58 (b) (3) (a) and Section 84 paragraph two of the Engineers Act B.E. 2542 (1999), which is a law authorizing the restriction of the rights and liberties of persons as permitted under Section 3 in conjunction with Sections 6 and 7 of the Constitution of the Kingdom of Thailand, the Council of Engineers, by resolution of its general meeting, hereby issues the following Regulations:

Clause 1 This regulation shall be called "Regulations of the Council of Engineers on the Issuance of Licenses to Practise the Regulated Engineering Profession at the Associate Engineer (Special) Level (No. 2), B.E. 2555."

Clause 2 This regulation shall come into force on the day following its publication in the Government Gazette.

Clause 3 Repeal Clause 1 of the Regulations of the Council of Engineers on the Issuance of Licenses to Practise the Regulated Engineering Profession at the Associate Engineer (Special) Level, B.E. 2547 (2004) and replace it with the following:

"Clause 1 An applicant for a license at the Associate Engineer (Special) level shall pass a knowledge examination for practising the regulated engineering profession, in accordance with the rules prescribed by the Council of Engineers."

Clause 4 Repeal Clause 4 of the said Regulations and replace it with the following:

"Clause 4 An applicant for a license at the Associate Engineer (Special) level who has filed an application shall undergo training and pass a knowledge examination on the practice of the regulated engineering profession \*\*in accordance with the curriculum/rules prescribed by the Council of Engineers."

The second paragraph shall apply to persons who have already completed the prescribed training and passed the knowledge examination and are ready to practise the regulated engineering profession.

Clause 5 Repeal Clause 10 of the said Regulations and replace it with the following:

"Clause 10 The issuance of a license at the Associate Engineer (Special) level shall be in accordance with the criteria, procedures and conditions prescribed under the Engineers Act B.E. 2542 and the relevant subordinate legislation, and the applicant \*must have passed the training and knowledge examination under Clauses 4 and 7."

Clause 6 The Regulation of the Board of the Council of Engineers on the Knowledge Examination for Practice at the Associate Engineer (Special) Level, B.E. 2548 (2005) shall continue to be used temporarily until a new regulation is issued pursuant to Clause 4 of the Regulations of the Council of Engineers on the Issuance of Licenses to Practise the Regulated Engineering Profession at the Associate Engineer (Special) Level, B.E. 2547 (2004), as amended by this regulation.
