

REGULATION OF THE COUNCIL OF ENGINEERS

on Qualifications of Persons Eligible to Sit for the Knowledge Examination for a License to Practice the Regulated Engineering Profession at the Associate Engineer Level

B.E. 2549 (2006)

Invoking the powers under Section 8(6)(จ)(ฎ)(ฏ) and Section 12(3) of the Engineer Act, B.E. 2542 (1999), together with Clause 3 and Clause 4 of the Regulation of The Council of Engineers on Recognition of Degrees, Diplomas or Qualifications Equivalent to Degrees in the Field of Engineering Science, B.E. 2543 (2000), and Regulation of The Council of Engineers on Issuance of Licenses to Practice the Regulated Engineering Profession at the Associate Engineer Level, B.E. 2549 (2006), and the Engineering Profession Act, B.E. 2505 (1962), the Council of Engineers (Thailand) – COET hereby prescribes the detailed qualifications of persons eligible to sit the knowledge examination for licensure to practice the Regulated Engineering Profession at the Associate Engineer (AE) level as follows:

Clause 1 This Regulation shall be called: “Regulation of The Council of Engineers on Qualifications of Persons Eligible to Sit the Knowledge Examination for the License to Practice the Regulated Engineering Profession at the Associate Engineer Level, B.E. 2549 (2006).”

Clause 2 Effective Date - This Regulation shall take effect from 1 January B.E. 2552 (2009).

Clause 3 Persons who have graduated from a program of study that has been accredited under the previous criteria pursuant to the Regulations issued under the Engineering Profession Act, B.E. 2505 (1962), and persons who have graduated from a program accredited under COET’s new criteria pursuant to the Regulation of the Council of Engineers on Recognition of Degrees, Diplomas or Qualifications Equivalent to Degrees in the Field of Engineering Science, B.E. 2543 (2000), shall be eligible to sit the engineering knowledge examination as determined by the Board of the Council of Engineers.

Clause 4 A person who has completed a foreign program that has not yet been recognized by the Council of Engineers (Thailand) shall, when applying for a license to practice the Regulated Engineering Profession at the Associate Engineer (AE) level, submit the program documentation and supporting evidence

to COET for case-by-case recognition. In considering such recognition, Regulation of The Council of Engineers on Recognition of Degrees, Diplomas or Qualifications Equivalent to Degrees in the Field of Engineering Science, B.E. 2543 (2000) shall apply mutatis mutandis
