## REGULATION OF THE COUNCIL OF ENGINEERS on the Issuance of Licenses to Practice the Regulated Engineering Profession (Adjunct Engineer) (No. 2), B.E. 2555 (2012)

Whereas it is deemed appropriate to amend the Regulations of the Council of Engineers on the Issuance of Licenses to Practice the Regulated Engineering Profession at the Adjunct Engineer

By virtue of the provisions under Sections 8 (6) (4) (7), and Section 46 of the Professional Engineers Act B.E. 2542 (1999), which is a law in accordance with the Constitution of the Kingdom of Thailand concerning the restriction and promotion of individual rights and liberties, and in conjunction with Sections 43 and 45 of the Constitution, the Council of Engineers, with the approval of the Extraordinary Council of Engineers Assembly and the consent of the President of the Council of Engineers, hereby issues the following Regulation.

Clause 1 This regulation shall be called "Regulations of the Council of Engineers on the Issuance of Licenses to Practice the Regulated Engineering Profession at the Adjunct Engineer (No. 2), B.E. 2555."

Clause 2 This regulation shall come into force on the day following its publication in the Government Gazette.

Clause 3 Repeal Clause 8 of the Regulations of the Council of Engineers on the Issuance of Licenses to Practice the Regulated Engineering Profession at the Adjunct Engineer, B.E. 2543 and replace it with the following:

"Clause 1 An applicant for a license at the Adjunct Engineer level shall pass a knowledge examination for practicing the regulated engineering profession, in accordance with the rules prescribed by the Council of Engineers."

Clause 4 Repeal Clause 4 of the said Regulations and replace it with the following:

"A person who has been granted a Special Professional Engineering License and has passed the knowledge examination under Clause 8 shall undergo training and an additional examination on professional knowledge and readiness to practice Regulated Engineering in accordance with the regulations prescribed by the Council of Engineers Committee.

The provision of the first paragraph shall not apply to those who have already completed the said training and examination on professional knowledge and readiness to practice Regulated Engineering Profession."

Clause 5 Repeal Clause 10 of the said Regulations and replace it with the following:

"Clause 10 The issuance of a license at the Adjunct Engineer shall be in accordance with the criteria, procedures and conditions prescribed under the Engineers Act B.E. 2505 and the relevant subordinate legislation, and the applicant must have passed the training and knowledge examination under Clauses 8 and 9."

Clause 6 The Regulation of the Board of the Council of Engineers on the Knowledge Examination for Practice at the Adjunct Engineer, B.E. 2544 (2001) shall continue to be used temporarily until a new regulation is issued pursuant to Clause 8 of the Regulations of the Council of Engineers on the Issuance of Licenses to Practice the Regulated Engineering Profession at the Adjunct Engineer, B.E. 2543, as amended by this regulation.
