

REGULATION OF THE COUNCIL OF ENGINEERS  
on the Issuance of License to Practice the Regulated Engineering Profession  
at the Adjunct Engineer (No. 4)  
B.E. 2564 (2021)

---

Whereas it is expedient to amend the Regulations of the Council of Engineers on the Issuance of License to Practice the Regulated Engineering Profession at the level of Adjunct Engineer, B.E. 2543, in order to comply with the Cabinet Resolution of 2 October B.E. 2561 (2018) on facilitation and burden reduction for the public by refraining from collecting fees for official documentary copies, and to facilitate and improve the efficiency of services of the Council of Engineers via electronic transactions under the law on electronic transactions;

Now, therefore, by virtue of Section 8 (6) (๑) (๒) and Section 46 paragraph two of the Engineers Act, B.E. 2542 (1999) and the Ministerial Regulation Prescribing Branches of the Engineering Profession and the Regulated Engineering Profession, B.E. 2550 (2007), the Council of Engineers, by the resolution of the General Meeting dated 11 February B.E. 2564 (2021), hereby issues the following Regulations:

Clause 1 These Regulations shall be called “Regulations of the Council of Engineers on the Issuance of License to Practice the Regulated Engineering Profession at the level of Adjunct Engineer (No. 4), B.E. 2564 (2021).”

Clause 2 These Regulations shall come into force on the day following their publication in the Royal Thai Government Gazette.

Clause 3 The provisions of Clause 4 of the Regulations of the Council of Engineers on the Issuance of License to Practice the Regulated Engineering Profession at the level of Adjunct Engineer, B.E. 2543 (2011), are hereby repealed and replaced by the following:

“Clause 4 An applicant for a License at the level of Adjunct Engineer shall complete and sign the application form and submit it to the Office of the Council of Engineers together with the following supporting documents:

- (1) Evidence of educational qualification (if any);
- (2) A recent photograph, taken within the past 12 months, full face without hat and without dark glasses, 2.5 cm in width × 3.5 cm in height, two (2) copies;
- (3) A statement of work and workload relating to the applicant’s practice in the Regulated engineering profession, in the form prescribed by the Council of Engineers, certified by an engineer of at least the level of Professional Engineer in the same branch and discipline as that applied for.”

Clause 4 Add the following provision as Clause 11 of the Regulations of the Council of Engineers on the Issuance of License to Practice the Regulated Engineering Profession at the level of Adjunct Engineer, B.E. 2543:

“Clause 11 Any request, application, License issuance, membership registration, administrative order or any act undertaken under these Regulations, if made in the form of electronic data and through electronic transactions, shall be deemed lawful and valid as if made in paper form.”

“Shall be applicable and produce legal effect under these Regulations. In this regard, the procedures shall be in accordance with the law on Electronic Transactions.”

Clause 5 (Transitional Provision) An application for a License to Practice the Regulated Engineering Profession at the level of Adjunct Engineer that was filed prior to the effective date of these Regulations shall continue to be processed to completion under the Regulations of the Council of Engineers on the Issuance of License to Practice the Regulated Engineering Profession at the level of Adjunct Engineer , B.E. 2543.
