Regulation of the Council of Engineers

Concerning Registration as APEC Engineer (APEC Engineer)

(No. 3) B.E. 2563 (2020)

Whereas it is deemed appropriate to further amend the Regulation of the Council of Engineers Concerning Registration as APEC Engineer B.E. 2552 (2009), by virtue of the authority vested under Section 33(3) of the Engineers Act B.E. 2542 (1999), in conjunction with the resolution of the Extraordinary General Meeting No. 1/2560 dated 6 July 2560, and the resolution of the Council of Engineers Meeting No. 10-10/2562 dated 10 October 2562, the Council of Engineers hereby issues the following Regulation:

Clause 1 This Regulation shall be called the "Regulation of the Council of Engineers Concerning Registration as APEC Engineer (No. 3) B.E. 2563 (2020)".

Clause 2 This Regulation shall come into force from the day following the date of its publication in the Royal Thai Government Gazette.

Clause 3 The provision in Clause 3 of the Regulation of the Council of Engineers

Concerning Registration as APEC Engineer B.E. 2552(2009) shall be repealed and replaced with the following:

"Clause 3 Any person wishing to receive the benefits of being an APEC Engineer shall submit an application for registration and a self-assessment of engineering competence, along with the application fee, to the Office of the Council of Engineers, using the application form, self-assessment form, and supporting documents as prescribed by the Council of Engineers."

Clause 4 The provision in Clause 6 of the Regulation of the Council of Engineers. Concerning Registration as APEC Engineer B.E. 2552(2009) shall be repealed and replaced with the following:

"Clause 6 The applicant shall present their work experience in the regulated engineering profession or the engineering profession, depending on the field applied for, to the Subcommittee on Registration of APEC and ASEAN Chartered Professional Engineers as appointed by the Council of Engineers, within the period specified by the Subcommittee. Applicants who are unable to present their work within the specified period must file a request to postpone the presentation via the Office of the Council of Engineers, not less than three days before the

scheduled date, unless force majeure applies. Such postponement may not be requested more than twice.

The Subcommittee may require the applicant to revise or supplement the submitted work or provide additional supporting documents as deemed appropriate for further consideration. The applicant shall comply and present within the timeframe specified by the Subcommittee.

If the applicant fails to complete the process within the specified time, it shall be deemed that the applicant no longer wishes to proceed with the registration.

In the event that the Subcommittee, upon examination, finds that the applicant meets the qualifications specified in Clause 4 or Clause 5, the matter shall be forwarded to the Council of Engineers for a resolution to register such person as an APEC Engineer, and the Office of the Council of Engineers shall notify the applicant in writing within sixty days from the date of the Council's resolution. Such notification may be made in the form of electronic communication if so, requested by the applicant."

Clause 5 For any application for registration that was submitted before the effective date of this Regulation, the process shall continue in accordance with the Regulation of the Council of Engineers concerning Registration as APEC Engineer B.E. 2552 and the Regulation of the Council of Engineers Concerning Registration as APEC Engineer (No. 2) B.E. 2560, until the process is completed.
